





Product and Service Information

Water Treatment Chemicals

We at Kurita began our foray into the water treatment chemicals business by selling boiler water treatment chemicals, and later going on to develop numerous chemical products, such as cooling water treatment chemicals, wastewater treatment chemicals and process treatment chemicals, thereby expanding and developing our target market as we grew. Our water treatment chemicals, which contribute to the stable and efficient operation of factories, air-conditioning systems, district heating and cooling systems, and other facilities, enjoy a strong reputation among our customers based on superior performance and quality. We also help customers resolve the issues they face through the realization of optimal water treatment applications, made possible through our nationwide sales network and attentive, customer-focused service.

Product Lineup

Boiler Water Treatment Chemicals

Steam-generating boilers have numerous applications, from use in factory processes through to air-conditioning applications in office buildings and hospitals. Boiler water treatment chemicals are used to minimize the various faults that may arise in boilers and to ensure that they continue to operate efficiently. Kurita provides the optimal treatment solution to suit customer needs using chemical products that are not only effective but also contain safe ingredients.

Cooling Water Treatment Chemicals

As with boilers, cooling water is also used during manufacturing processes and for air-conditioning in factories and office buildings. Cooling water treatment chemicals act to prevent problems from occurring in pipes and cooling units and heat exchangers, and also prevent the growth of the harmful Legionella bacteria. They help to enhance operational efficiency, which in turn contributes to the establishment of a resource- and energy-efficient, not to mention, safe workplace environment.

Wastewater Treatment Chemicals

Wastewater treatment chemicals are used to treat the many forms of industrial wastewater discharged by factories and domestic sewage to ensure that they do not impact upon the local environment. An extensive range of application-specific chemicals are used for deodorization and the removal of suspended solids. Kurita stays one step ahead of the trends in drainage regulations in its ongoing development of wastewater treatment chemicals, reducing the environmental impact of wastewater through appropriate wastewater treatment.

Process Treatment Chemicals

Our process treatment chemicals are designed to improve production efficiency in the manufacturing processes used in the oil refining, petrochemical, steel, and pulp and paper industries. The survival of companies in the world of manufacturing hinges largely on their ability to improve quality and reduce costs. At Kurita, we strive to develop and offer products that will help our customers achieve these goals.

Incinerator Chemicals

We also produce chemicals to eliminate harmful substances from the incinerator ash and fly ash discharged by the more than 10,000 incinerators run by local authorities and private enterprises nationwide. Incinerator ash and fly ash are known to contain various toxins, including lead and other heavy metals as well as dioxins. Kurita's incinerator chemicals provide safe methods to treat such harmful substances. Our products function by preventing the discharge of heavy metals in fly ash and by suppressing the generation of dioxins within incinerators.

水処理薬品

クリタの水処理薬品事業は、ボイラ薬品の販売からスタートし、以後、冷却水薬品や排水処理薬品、プロセス薬品など、市場ニーズを的確にとらえたさまざまな薬品を数多く開発し、対象となる市場を広げながら発展してきました。工場や空調設備(施設) あるいは地域冷暖房施設などの安定的で効率的な操業に貢献する高機能で高品質な水処理薬品は、お客様から高い評価を得ています。さらに、全国に広がる販売ネットワークを構築し、お客様に密着したきめ細かなサービスを提供するなど、最適な水処理の実現によってお客様の課題解決に貢献しています。

商品ラインアップ

ボイラ薬品

蒸気を発生させるポイラは、工場でのプロセス用から、オフィスビルや病院などにおける空調用まで、幅広く使用されています。ボイラ薬品は、ボイラで発生するさまざまな障害を抑えて、ボイラを効率よく運転するために使われます。 クリタは、効果はもちろん原材料の安全性まで考慮した薬品によって、用途に合わせた最適な処理を行います。

冷却水薬品

ボイラと同じく、ほとんどの工場やオフィスピルでは冷却水がプロセス用や空調用として使用されています。冷却水薬 品は、配管や熱交換器における障害や、冷却塔における有害なレジオネラ菌の増殖などを防止するものです。 運転効率 の向上による省資源・省エネルギーや安全な職場環境づくりに貢献します。

排水処理薬品

排水処理薬品は、工場などで発生するさまざまな性状の産業排水や生活排水を、周辺の環境に影響を与えないように処理するものです。排水中の懸濁物質除去や消臭・脱臭など、用途別に数多くの薬品が使用されています。クリタは排水 規制などの動向を先取りしながら排水処理薬品の開発を進め、適切な排水処理による環境負荷の低減を実現しています。

プロセス薬品

プロセス薬品は、石油精製・石油化学、鉄鋼、紙パルブ産業などの製造工程において、生産効率の維持・向上に用いられる薬品です。 製造業においては品質向上とコストダウンが企業存続のカギを握っており、これらの課題を解決する薬品の開発・提案を積極的に進めています。

焼却炉関連薬品

自治体や民間企業が所有する全国10,000基以上のゴミ焼却炉から発生する焼却灰や飛灰中の有害物質を除去するために使用します。焼却灰や飛灰には鉛をはじめとする重金属類やダイオキシン類などの有害物質が含まれており、クリタの焼却炉関連薬品は、飛灰中の重金属の流出防止や、清掃工場におけるダイオキシン発生の抑制機能により、有害物質を安全なかたちで処理します。

Equipment and Systems for Water Treatment Chemicals

Not only do we specialize in water treatment chemicals, we also have a range of equipment and systems on offer, including chemical dosing systems and automatic boiler and cooling water quality control systems. Furthermore, Kurita boasts an array of filters for use in water treatment, as well as the filter media, activated carbon or ion-exchange resin used in such devices, which, when used in combination with our water treatment chemicals, create the optimal treatment system.

Customized Services

On top of the water treatment chemicals and equipment that Kurita provides, it also offers customized services, including operations and management services such as Kurita's Steam Supply Service.

■ Steam Supply Contract

Based on the operations and management know-how we have accumulated over our many years in the business, Kurita operates under a business model where we install, own and operate boiler facilities to provide a stable supply of steam at a guaranteed quality to customers according to a usage-based pricing schedule.

■ Blanket Contracts for Factories

Customers can choose to outsource to Kurita all water treatment chemical-related functions, from the selection of chemicals used in boiler water, cooling water and wastewater treatment to the setting and control of chemical amounts used across an entire factory. As specialists in water treatment, Kurita can provide optimal water treatment management on a factory-wide basis, realizing significant cost and efficiency advantages.

■ Water Treatment Management Contract Using Remote Water Monitoring System

Kurita monitors data on the quality of boiler water, cooling water and wastewater, as well as the volume of chemicals used in our customers' factories via our around-the-clock communications network to prevent any potential problems from occurring.



Product and Service Information

Water Treatment Facilities

From the production of ultrapure water that is virtually impurity-free to the treatment of industrial wastewater and domestic sewage, Kurita develops essential water treatment facilities for a wide variety of applications and continues to contribute to the development of industry and prevention of pollution. Applying the water treatment technology we have cultivated to date, we at Kurita have extended the scope of our business to include soil remediation. We have also established a nation-wide maintenance service network to ensure that the systems we deliver operate stably at all times. We make sure that our customers' systems and facilities continue to operate at peak efficiency, not only by responding immediately to problems that occur but also by putting forward active suggestions for improvements and upgrades. Furthermore, by leveraging the know-how gained through our maintenance services, we have built a business model that includes the provision of comprehensive solutions and outsourcing services. Through this integrated approach, we help customers reduce their environmental impact and bolster productivity.

Product Lineup

Water Treatment

■ Ultrapure Water Production Systems

These systems produce water that is as close as possible to theoretically pure H₂O—an essential ingredient in the production of semiconductors and flat panel displays (FPDs). Using this system, ions, microscopic particles and bacteria are removed from the water to a very high degree. Kurita provides water of extremely high purity and in doing so is furthering the development of the electronics industry.

■ Pure Water Production Systems for General Industries

Water is also used in a host of other industries besides the electronics industry. For example, even the most minute bacterial contamination is unacceptable for water used in pharmaceutical manufacturing processes. Kurita's water production systems for the pharmaceuticals industry employ the technology developed for Ultrapure Water Production Systems to manufacture and supply safe water. In addition, for such industries as electric power generation, food processing and steel, our expertise and system design capabilities enable us to provide customers with the particular grade of water required for each application.

Wastewater Treatment

■ Wastewater Treatment and Wastewater Reclaim Systems

Wastewater treatment systems act to detoxify the many forms of industrial wastewater discharged by plants and industrial complexes to ensure that it does not negatively impact upon the surrounding environment. Kurita's systems not only provide a safe means of treating wastewater, they are also designed to reduce the volume of wastewater and waste products actually generated. Furthermore, the wastewater itself and the marketable substances found therein are treated and reclaimed to produce water of reusable quality, which contributes to the conservation of resources and cost reductions.

■ Sewage Treatment Facilities

Sewage treatment facilities function to treat septic waste in a safe manner. In recent years, these facilities have also been involved in resource recycling activities, including the manufacture of compost from sludge, energy recovery via methane fermentation and the recovery of valuable materials, such as phosphorous.

水処理装置

不純物をほとんど含まない超純水の製造から産業排水や生活排水の処理まで、クリタはさまざまな場面で必要とされる水処理装置を開発し、産業の発展や環境汚染の防止に貢献してきました。水処理で培った技術を応用し、現在では土壌の汚染浄化にまで事業領域を広げています。また、納入した装置の安定運転を実現するために、メンテナンス・サービス網を全国に整備しています。トラブルに対する迅速な対応だけでなく、積極的な改善提案によってお客様の装置を常に最良の状態に維持しています。さらに、メンテナンス事業を通じて得られたノウハウを活かし、総合的なソリューションの提供やアウトソーシング事業などのビジネスモデルを構築し、環境負荷の低減や生産性の向上といったお客様の課題解決に貢献しています。

用水処理

■ 超純水製造システム

半導体やFPDの製造に欠かせない、理論純水に限りなく近い水をつくるシステムです。水中からイオンや微粒子、細菌などを除去し、きわめて高い純度の水を提供することで電子産業の発展に貢献しています。

■一般産業向け用水処理装置

半導体などの電子産業以外にもさまざまな産業において水は使われます。例えば医薬品の製造工程で使用される水には、わずかな雑菌の混入も許されません。クリタの医薬用水製造装置は、超純水製造システムで培った技術によって、安全な水を製造・供給しています。このほか、電力・食品・鉄鋼といった産業においても、クリタは水処理に関する知見とシステム設計力により、お客様の必要とするグレードの水を提供しています。

排水処理

■ 排水処理・排水回収装置

排水処理装置は、工場やコンピナートなどから排出されるさまざまな性状の産業排水を周辺の環境に影響を与えないように無害化処理する装置です。クリタは、排水の安全処理だけでなく、排水量や廃棄物量の削減も考慮したシステムを提案しています。さらに、排水そのものや、排水中に含まれる有価物を再利用可能な状態に処理・回収することによって、省資源化とコストダウンに貢献します。

■下水処理施設

下水処理施設は、下水を安全なかたちで処理する施設です。近年では、従来廃棄物となっていた汚泥の堆肥化やメタン発酵によるエネルギー回収、 りんなどの有価物回収も行っています。

Service Business

■ Maintenance Services

Through our nationwide maintenance and service network, we prevent problems from arising in systems and facilities supplied to customers. Kurita also helps customers resolve any problems they may have by providing suggestions on improvements or upgrades that can be made to cut costs or to boost performance in terms of water quality or quantity.

Outsourcing

Kurita operates under a business model that aims to ensure stable operations while providing cost savings through our Ultrapure Water Supply Business. We install, own and operate water treatment facilities and supply customers with ultrapure water. We also provide Operations and Management Contracts, under which our on-site staff operate and manage water treatment and sewage treatment facilities for customers, and offer Inspection Circuit Maintenance Contracts, under which staff regularly monitor the facilities of our customers.

■ Soil Remediation

Kurita conducts pollution assessments and remediation of soil polluted by harmful substances. A Kurita Group company, Land Solution Inc., provides a range of services for the assessment of land utilization and the local environment, followed up by services for the hedging of pollution risks and the smooth sale of such land.

■ Tool Cleaning

At our own factories, we can clean and remove any deposits that adhere to tools used in the manufacture of semiconductors and flat-panel displays (FPDs). The provision of tool cleaning services helps customers to maintain and improve their productivity, and also enables Kurita to safely dispose of the contaminant removed, helping to alleviate the environmental burden of our customers' business operations.

■ Chemical Cleaning

Kurita also provides chemical cleaning services using chemical reagents and high-pressure water to clean boilers and heat exchangers, ensuring that large-scale plant facilities—found mostly in industrial complexes and electric power plants—continue to operate safely and efficiently.

■ メンテナンス・サービス

全国に広がるメンテナンス・サービス網によって、お客様に納入した設備・装置のトラブルを未然に防止します。 また、コストダウンや水量・水質の性能アップなどのニーズに対応した改善・改造策の提案によって、お客様の課題 解決に貢献します。

■アウトソーシング

■土壌浄化



■ 精密洗浄

半導体や液晶の製造装置の部品に付着した汚れをお客様に代わって、クリタの工場で洗浄・除去する事業です。 お客様の生産性の維持・向上に貢献するだけでなく、除去した汚れもクリタが安全に処理することで、お客様の環境負荷も低減します。

■ 化学洗净

主にコンピナートや発電所などの大型プラントを安全かつ効率的に稼働させるため、ボイラや熱交換器などを薬品や高圧水を使って洗浄する事業です。
