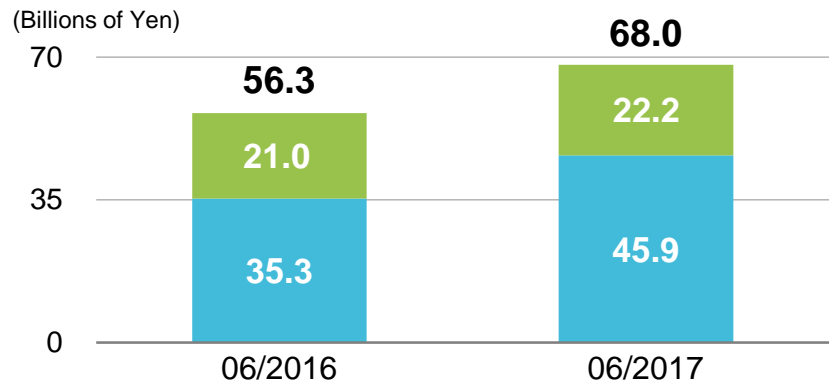
- Orders increased significantly primarily due to large orders in the Water Treatment Facilities business in Japan and overseas.
- Net sales rose in both the Water Treatment Chemicals business and the Water Treatment Facilities business.
- Operating income decreased due to a rise in selling, general and administrative expenses.

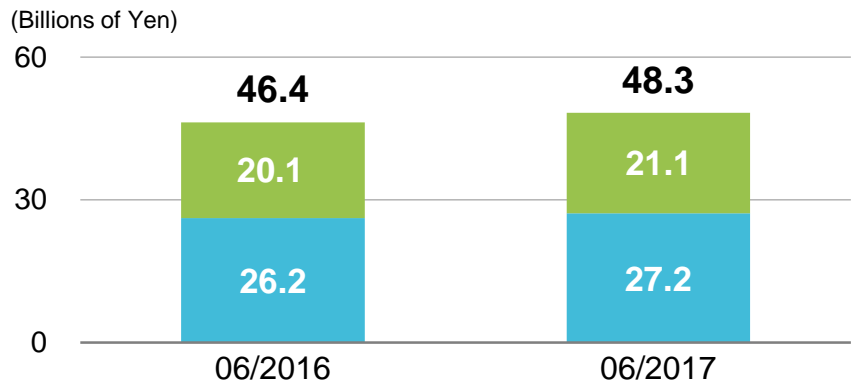

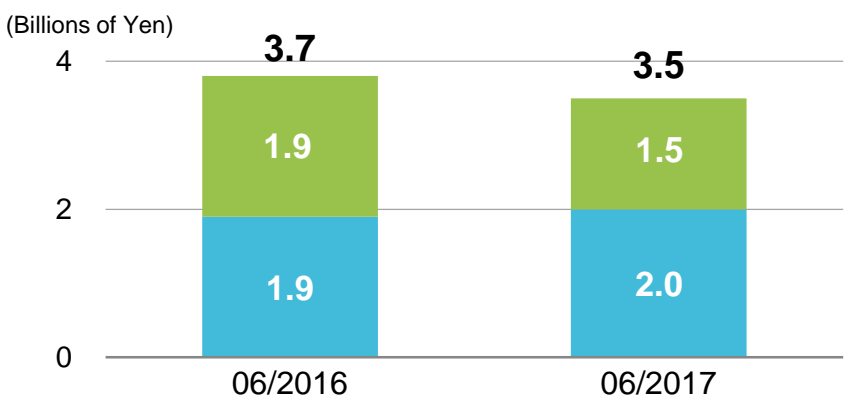

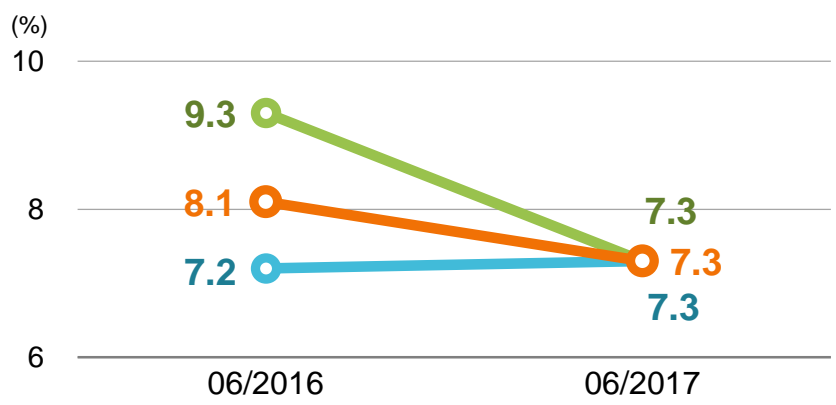

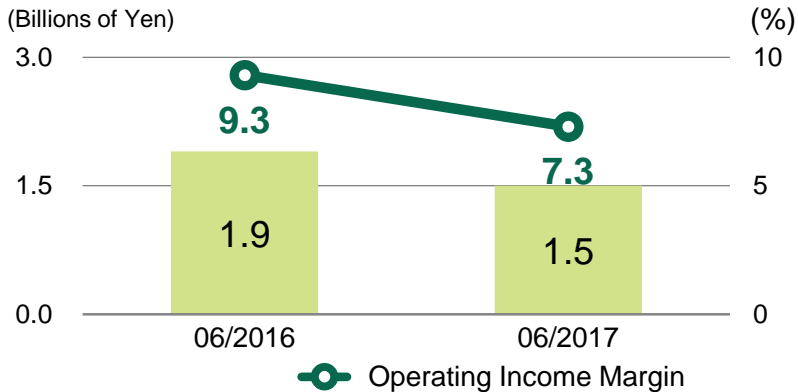
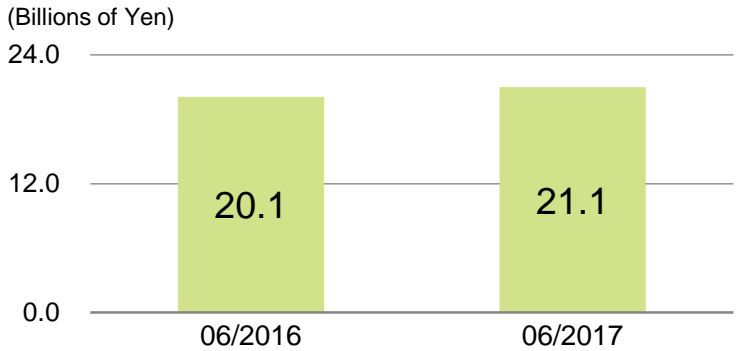
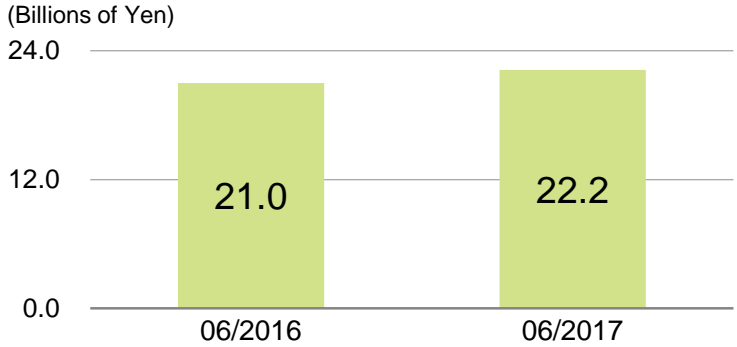
Operating Income

3. Water Treatment Chemicals



Orders

- Domestic orders increased for mainstay products such as those for boiler water and for cooling water, while orders for process treatment chemicals, etc. also increased.
- Overseas orders increased due to the inclusion of Fremont Industries, LLC in the scope of consolidation, but decreased if Fremont is excluded.

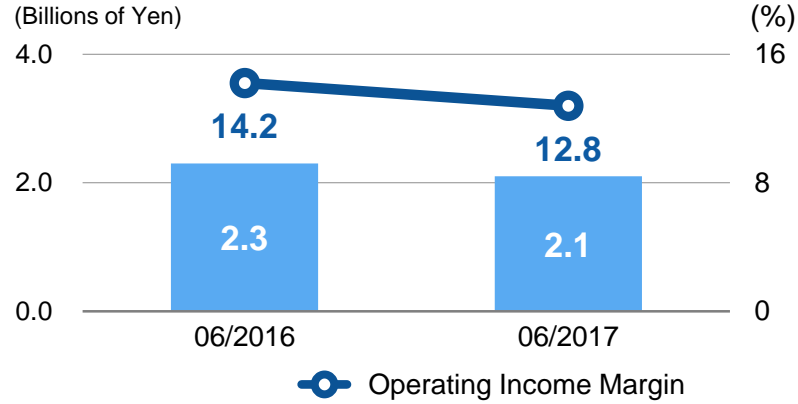
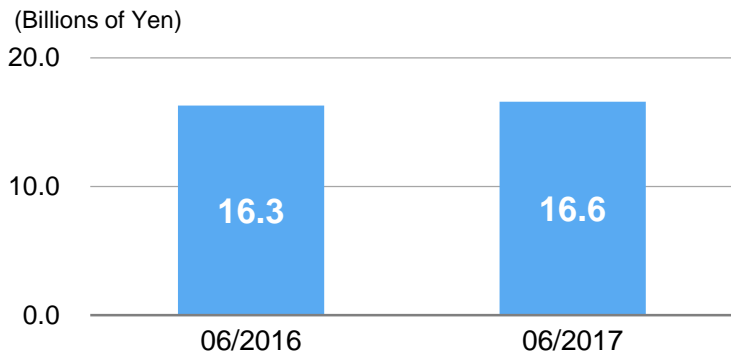
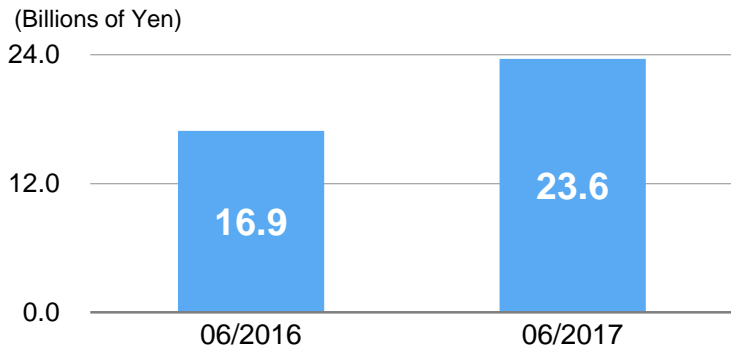
Sales

Operating Income

- Although the cost of sales ratio remained flat, operating income decreased due to a rise in selling, general and administrative expenses and a decrease in sales in Asia.

4. Water Treatment Facilities (for the electronics industry)



Orders

- Orders for hardware in Japan increased due to large orders for semiconductors.
- Orders for maintenance services in Japan increased due to expansion and modification of facilities.
- Orders for hardware increased overseas mainly in South Korea.
- Orders in the ultrapure water supply business declined due to revision of contracts.

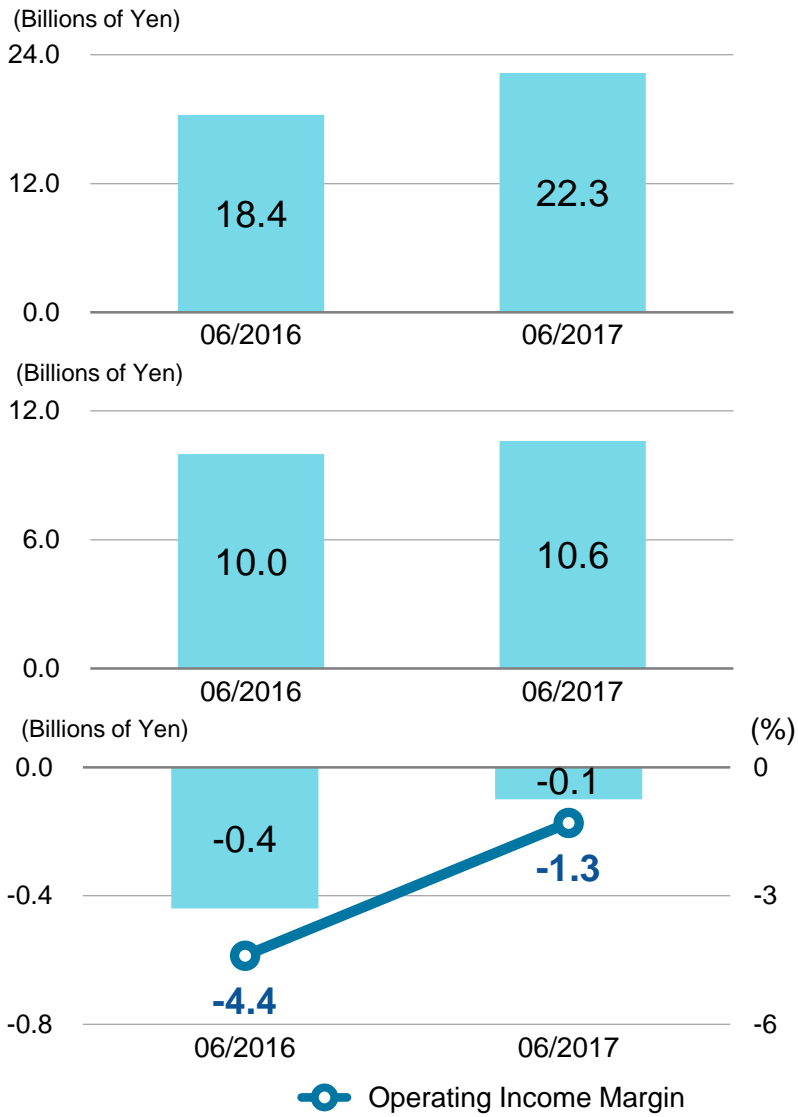
Sales

- Sales of hardware increased in Japan and overseas due to the progress of construction work.
- Sales of maintenance services in Japan increased in line with the rise in orders.
- Sales of the ultrapure water supply business declined due to revision of contracts.

Operating Income

- Operating income was affected by the decline in sales in the ultrapure water supply business.
- The rise in maintenance sales in Japan had an impact.
- The cost of sales ratio improved for overseas hardware.

5. Water Treatment Facilities (for general industries)



Orders

- Orders for soil remediation increased due to orders for large scale projects.
- Orders for maintenance services for general industries increased due to demand associated with renovating old facilities and demand for expansion.
- Orders for hardware from electric power industries increased.

Sales

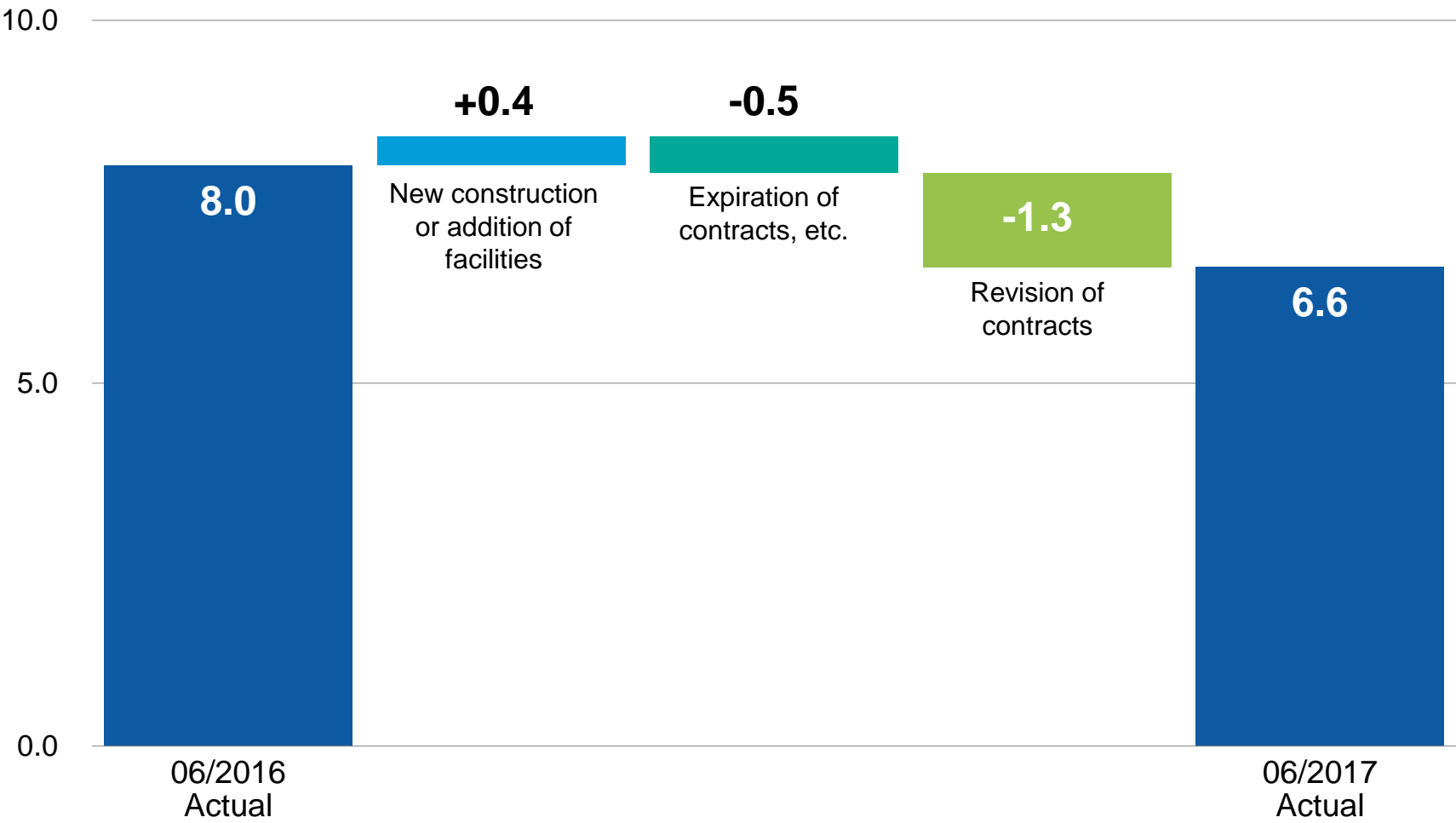
- Soil remediation sales increased due to the progress of construction work.
- Sales of maintenance services for general industries increased in line with the rise in orders.

Operating Income

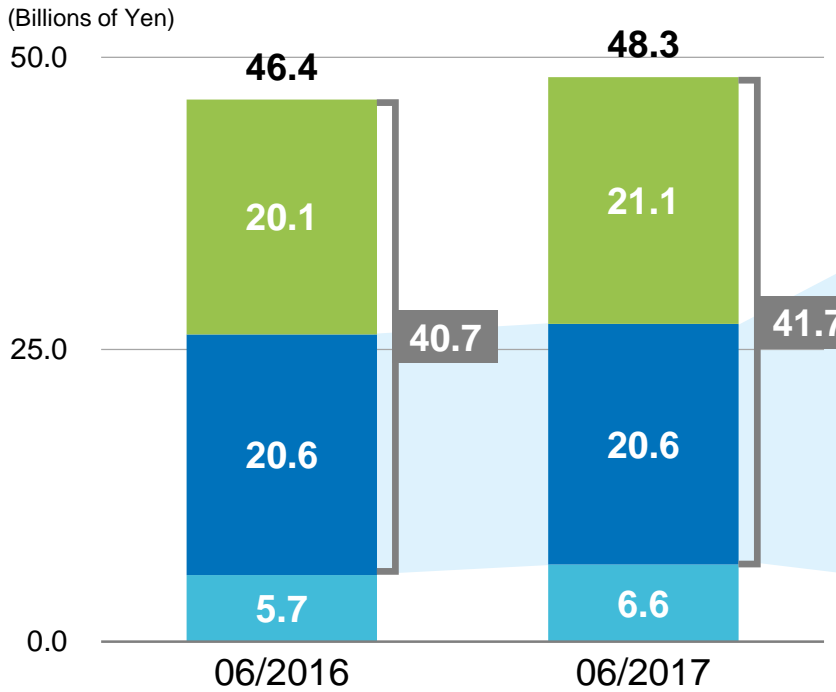
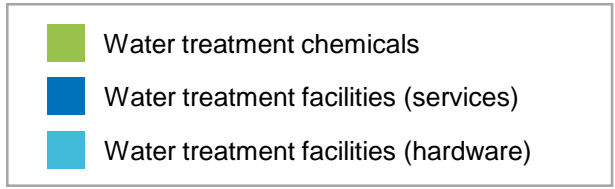
- The cost of sales ratio improved for both hardware and services.

6. Ultrapure Water Supply Business Revenue

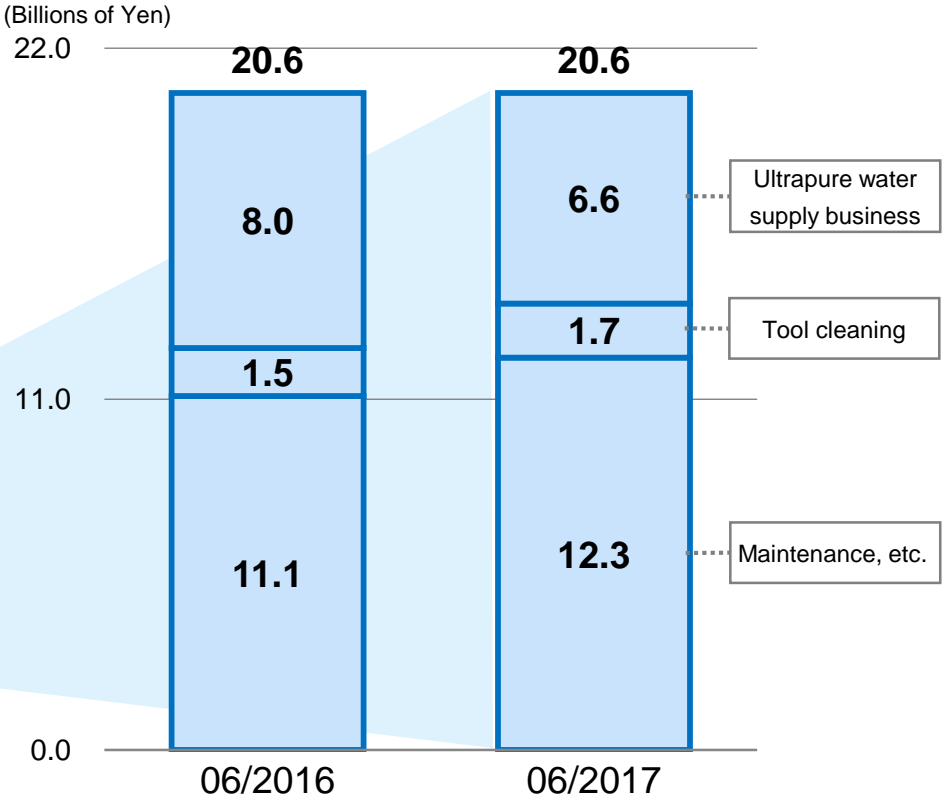

7. Service Business Revenue

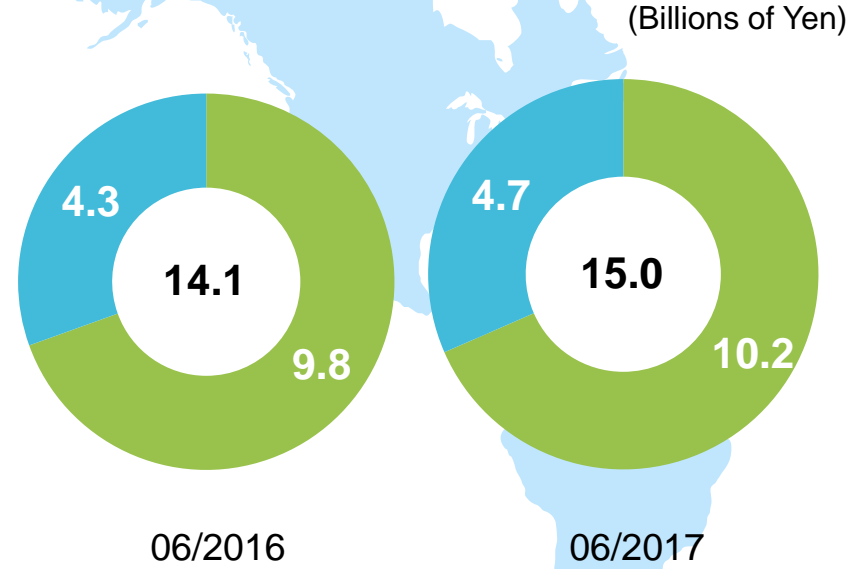
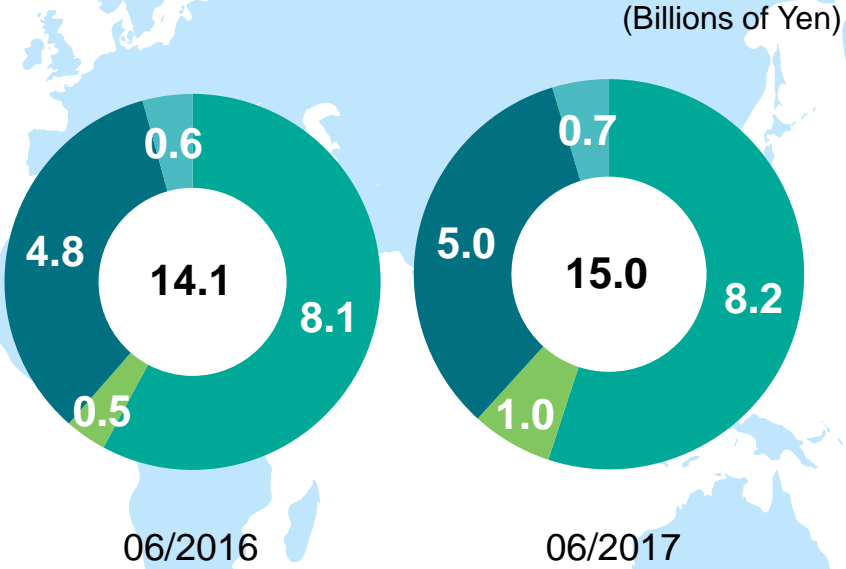
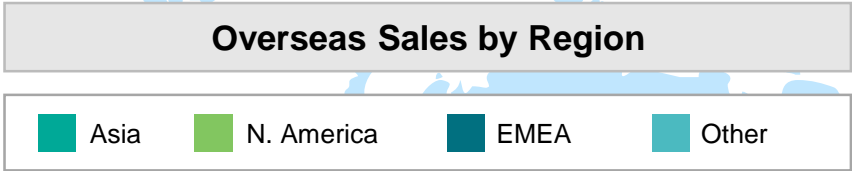


Service Business Revenue in the Water Treatment Facilities Segment



■ Revenues from the ultrapure water supply business declined, but those from maintenance and others increased steadily.

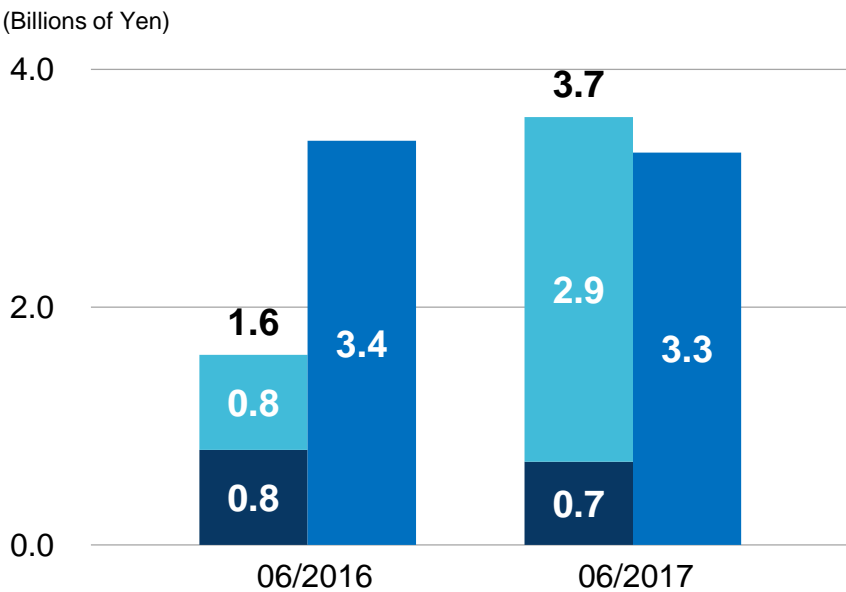
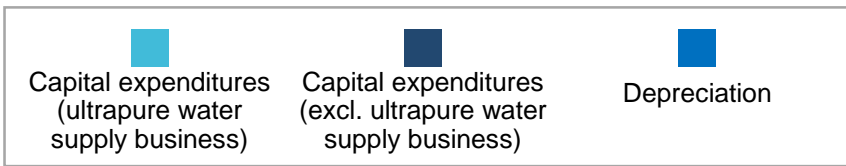
8. Overseas Business Revenue

- In the Water Treatment Facilities business, sales rose mainly in South Korea.

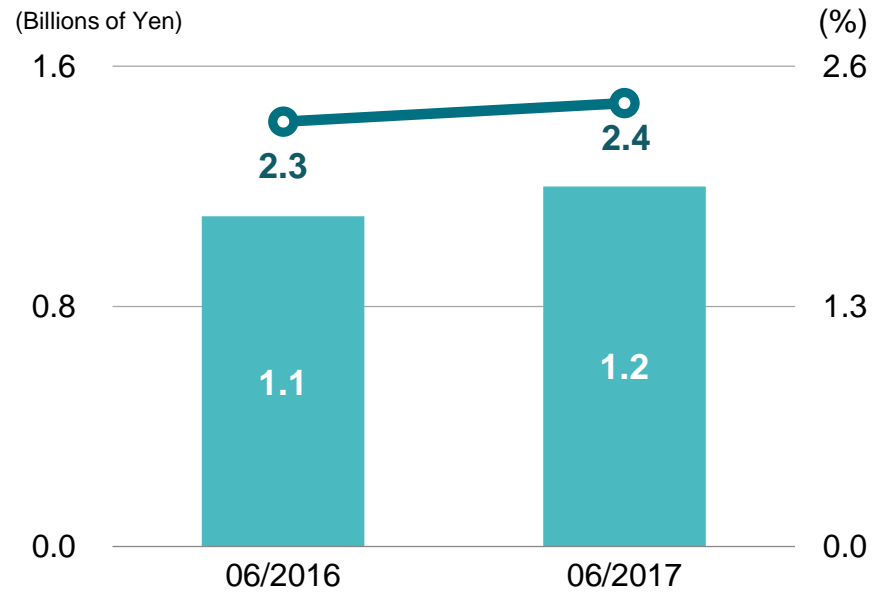
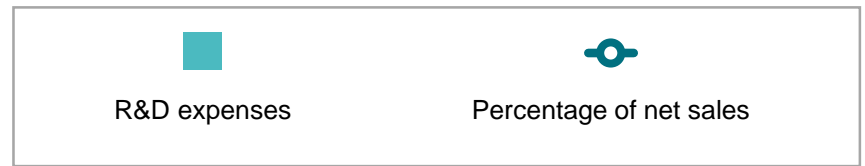
9. Capital Expenditures, Depreciation and R&D Expenses

R&D Expenses

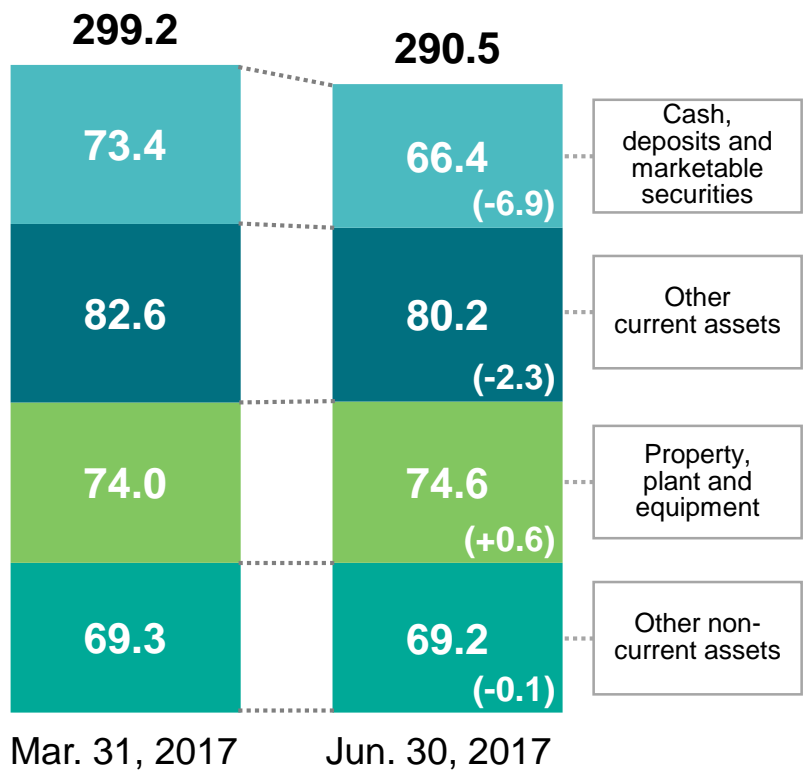


- R&D expenses increased as planned.

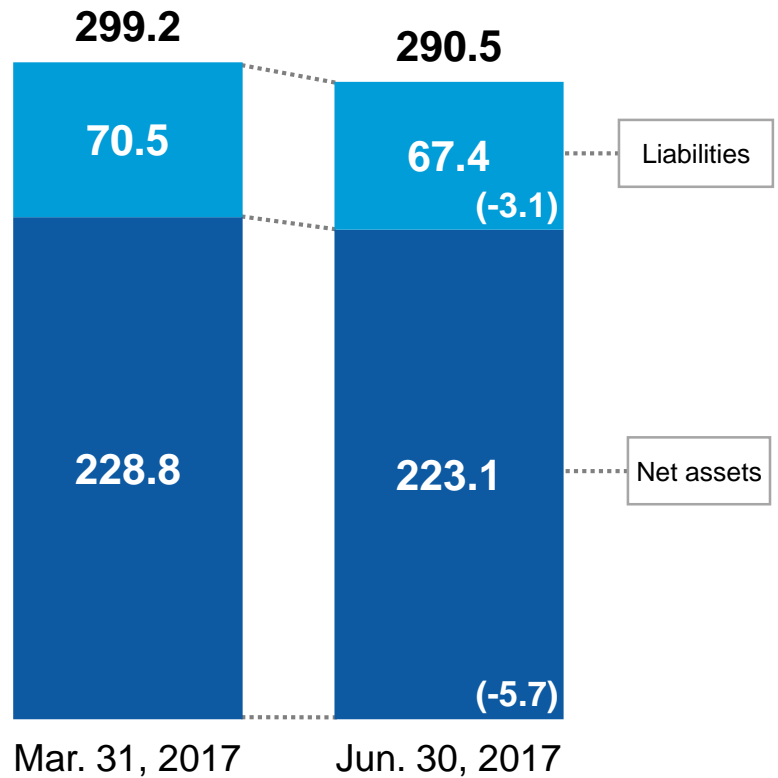
Assets
